The sealing tape Nexler Tasma Uszczelniająca 120/70 is intended to use to increase tightness of places exposed to moisture (comers, wall-to-floor joints, places where installation elements pass, etc.) and to ensure tightness in places, where strains caused by shrinkage and thermal cracks occur, except for structural dilatations during making waterproof insulation coatings inside buildings. It can be used as a sealing under ceramic tiles. The sealing tape Nexler Taśma Uszczelniająca 120/70 can also be used outside buildings as a reinforcing insert in the area of thermal expansion joints during under-tile waterproofing coating of balconies and terraces, made of compounds or polymer-cement mortars, placed on the market in accordance with the valid regulations and the intended use.
